
















Why Are We Here



- New York State Constitution (1777) mandates that a vote be taken every 20 years to answer the question "Shall there be a convention to revise the constitution and amend the same?"
- 9 Constitutional Conventions have been held
- We are now governed by the 1894 Constitution, which has been amended over 225 times
- Last Constitutional Convention was held in 1967recommended changes failed
- Last vote to hold a Constitutional Convention 1997

Convention is Not the Only Way



- Passage of individual amendments may be proposed in the state legislature
- Has been used 200 time since 1894
- Amendment must pass 2 consecutive legislative session, with an intervening statewide election
- Put to voters for approval
- If approved becomes part of the Constitution the following January

Timeline



- Voters decide: Whether to hold a convention
- November 7, 2017
- Who will be a delegate
- November 6, 2018
- Whether to accept or reject amendments
- November 5, 2019

Delegates



- Delegates elected by the people
- Complicated process in election law, not the Constitution
- 3 delegates for each Senate district and 15 statewide at large candidates
- Delegates who wish to appear on party primary ballot need to submit a petition with at least 1,000 signatures or 5% of the enrolled party voters residing in their district
- Candidates running as independent need 3,000 signatures or 5% of the votes cast in the district at the last election for Governor
- Statewide at large require 15,000 signatures.
- Once at the convention delegates determine leadership structures , procedures for public hearings and weekly schedules.
- Delegate operations are not mandated. Major criticism of the 1967 lack of public hearings and lack of transparency. Much of work was left to the end of the convention.
- Delegates earn \$79,500.00
- Costs of Convention may be higher than \$336.5 million. Cost of staff is very high, leaders have staff and each committee has staff Last convention there were approximately 250 staff and 58 paid interns.

- Article I- Bill of Rights- trial by jury, freedom of worship, vright to assemble...
- Article II-Suffrage-absentee voting, registration , election board..
- Article III-Legislature- senate districts, compensation, powers of each houses, passing bills, emergency governmental operation...
- Article IV-Executive-qualifications of Governor, powers and duties...
- Article V- Officers and Civil Departments-comptroller, attorney general...
- Article VI- Judiciary-court system, removal of judges, expenses of court...
- Article VII-State Finances-budget bills,vdebt...
- Article VIII-Local Finances-local indebtedness, limitations on debt...
- Article IX-Local Governments-powers and duties...
- Article X-Corporations- formation, liabiltites...
- Article XI-Education
- Article XII-Defense- militia
- Aritcle XIII-Public officers-oath, political year, compensation...
- Article XIV-Conservation-forest preserve, resevoirs

What's In the NYS Constitution

- Article XV-Canals-lease, disposition...
- Article XI-Taxation- power of taxation, exemptions..
- Article XVII-Social Welfare-public relief and care, public health inspections...
- Article XVIII Housing-nursing homes, low rent housing , acquisition of property...
- Article XIX- Amendments
- Article XX- time to take effect

Education Related Issues



- Funding for "common schools". "the legislature shall provide for the maintenance and support of a system of free common schools, wherein all the children of this state may be educated."
- Board of Regents-oldest state education policy board in the U.S. Established in 1794 as part of the state constitution granting the board the power to determine educational policy
- Blaine Amendment which prohibits use of public dollars for private schools
- Pensions for public employees-this right is contractual and not subject to diminution so that public pension benefits may not be reduced
- Right to workman's compensation
- Right to social welfare needs
- Right to unionize and collective bargaining

Other Ideas



- Provide unqualified funding statewide for the cost of a sound basic public-school education through high school.
- Alternatively, defer to the Legislature to determine the appropriate fiscal limitation if any on implementing a sound basic public-school education.
- Establish the goal of "equality of educational opportunity" for all residents of New York State.
- Expand the Court of Appeals standard of a "sound, basic education" to include preparation for higher education.
- Eliminate the 19th-century reference to a system of "free common schools."
- Aid religious schools (the Blaine Amendment)

Other Reasons



- Strengthen anti-discrimination provisions:
- Strengthen the current Article XVII, which guarantees "aid, care, and support to the needy," and/or reconsider impact of the provision on mandated local expenditures.
- Create a right to healthcare.
- Expand privacy rights.
- Diminish reliance on money bail and create a presumption for release for nonviolent offenses.
- Impose limitations on outside income for all State public officials, such as by following the Congressional model of a 15 percent cap on outside income.

And More



- Establish a constitutional right in either the Environmental Conservation Article or State Bill of Rights to clean air and clean water, enforceable against public officials and agencies.
- Allow registration for those who are sixteen and seventeen years old, which becomes effective when they turn eighteen;
- Reform election financing:
- Reconsider the organization of the Executive Branch including the cap on the number of departments and agencies.
- Provide for term limits for legislators and legislative leadership.
